



Subject to 80 years in prison and \$1 million fine


#### Chen's Case

### 05/21/2015 Press Conference



- Held in Cannon House Building
- Led by Rep. Ted Lieu, Judy Chu, Mike Honda
- 6 Asian American organizations joined
- Congressional inquiry to Attorney General by 22 Congressional members


#### 05/21/2015 Congressional Inquiry

- Investigate whether race and national origin were factors in the case of Sherry Chen
- Investigate whether race, national origin, religion or gender are being used by Federal agencies in targeting
   Federal employees



"...National Insider Threat Program..."

### 07/27/2015 DOJ Response



- "...received assurances from USAO and FBI ... that race played no role ..."
- "...No policy exists for using race or any other civil rights classification to 'target federal employees..."

# 09/04/2015 Community Letter



- Fully support
   Congressional request
   for investigation
- "Asian Americans and Racial Profiling"

- Historical facts
- Inflammatory rhetoric
- Culturally insensitive
- Appearance of pattern and practice

"The charges filed against Mr. Xi and Ms. Chen traumatized them and their families and needlessly damaged their professional reputations. Neither got an explanation or an apology from the government. They deserve both."

### 09/16/2016 C-100 Training



Paraphrasing from Professor Xi:



"If we could start all over again, I do not know what I could do differently to avoid what has happened"

#### Where Are We Now?

- Sherry Chen. All criminal charges were dismissed, but the National Weather Service notified her of their intention to fire her
- Xiaoxing Xi. He is trying to return to a "normal" life at Temple University. His daughter Joyce is visiting the Bay area to raise understanding and awareness
- Congress. Continuing to call for an independent investigation by DOJ. A second Congressional letter is being prepared
- Community. ??
